Columbia to Host Fourth Society Convention

Fourth/167th Society Convention to be held in New York City from October 14-17, 1999

The Fourth Alpha Delta Phi Society Convention and Leadership Training Conference will be held from October 14-17, 1999, at the Columbia Chapter on the campus of Columbia University in New York City.

The Columbia Chapter hopes you will join them for a fun-filled weekend meeting with old and new Alpha Delts while working to continue the development and growth of our young organization.

While the convention is the central governing mechanism for the Society, it is also a time for socializing with Alpha Delts from around the nation. Each chapter and graduate organization will send a delegate and alternate as official representatives, but all members of the Society are encouraged to attend the business sessions and social activities. Stanford Chapter Hosts Board and Caucus

The weekend of April 9-11, 1999 marked two major milestones in the history of the Alpha Delta Phi Society. For the first time in the Society's seven-year history, the Board of Governors held a meeting hosted by the Stanford Chapter. Stanford also hosted the largest Society-wide gathering of graduates and undergraduates to date, as 81 Alpha Delts, representing each of the six chapters, enjoyed a reception and banquet on Saturday night.

The combined Board of Governors and undergraduate caucus weekend was a tangible realization of the Society's commitment to ensuring the success of the Stanford Chapter. The Stanford Chapter in recent years has suffered from the lack of official housing and recognition in the university Greek system. Despite these potential handicaps, last year's pledge class brought new life to the chapter. The chapter also regained official recognition. As a result, the Stanford graduate organization's officers concluded in January that the time had come for a Board and caucus meeting at Stanford.

Chapter News

The **Bowdoin Chapter**, which must close because of a recent college mandate, plans to remain active until the last possible moment—the end of the 1999-2000 academic year. The chapter graduate corporation is currently examining various options for the use of the chapter house after the Greek system is disbanded. In addition to the awarding of the Franklin Delano Roosevelt Cup (given to the member of the lower three classes who has contributed the most to life at Bowdoin College), other literary events include the chapter sponsored Geoffrey Stanwood Memorial Literary Competition which is now in its third year.

The **Brunonian Chapter** has 14 pledges for the coming year. Brunonian will have 58 members to start the 1999-2000 academic year. This semester, the chapter has hosted a literary sleepover, the popular Still Fondue rush event, an "Open Mike" night, and has started to develop a new literary magazine. On April 22, the Chapter raised \$4,182 with its annual "Bizarre Bazaar," the largest community service effort at Brown University.

There are currently 50 members at the **Columbia Chapter**, filling the chapter house to capacity. The Chapter once again hosted "Hot Jazz and Cold Champagne," the largest social event at Columbia. The chapter also hosts a successful literary program every other Thursday night. The **Middlebury Chapter** boasts a membership of 92 Alpha Delts, and the chapter house is filled to capacity. Members have hosted and participated in community service events for battered women's support, multiple sclerosis, and Habitat for Humanity. Middlebury professors and graduates of the chapter host talks at the house, and the chapter is adding to its new chapter with graduate support.

After a surge in pledging during the fall and the addition of eight pledges this spring, the **Middletown Chapter** has rebounded and has 34 members. The undergraduates plan additional growth and expansion in the fall. The chapter participates in Earth Day events as part of its community service program, and continues to invite professors to the chapter house for dinner and to participate in Middletown's literary program.

The **Stanford Chapter** hosted the Society's Board of Governors and undergraduate caucus the weekend of April 9-11. In addition to the meetings, Stanford hosted a banquet attended by 81 Alpha Delts from all chapters in the northern California area. The active membership of the chapter has increased to 16 after a successful fall rush. The chapter alternates hosting social and literary events on Wednesday nights which draw graduates back to the chapter to allow them to maintain a strong connection with the undergraduates.

Society Fundraising Report

The Society's new fundraising policy is working, but a large response from the last fundraising letter of the year is necessary to make the new policy an unqualified success.

The Society has received \$8,242 from 131 contributors through March 31, 1999. The comparative figures for the previous year were \$8,297 from 126 contributors. The success or failure of this year's budget will hinge on the third fund-raising mailing, which will include the *Society Xaipe*. Last year, this mailing raised \$12,756 from 93 contributors. This year's mailing will have to do well in order to reach our fiscal year fundraising goal of \$17,000.

As a result of the new policy, fundraising expenses this year have dropped from \$5,000 on April 15 last year to \$1,600 this year. Consequently, the net proceeds to the Society (after expenses) this year are better than any year in the Society's history. This is due to the new fundraising policy adopted by the Board of Governors at its October 1998 meeting held at the Columbia Chapter.

The new policy sends first-class mailings twice a year to those members who have supported the Society by contributing at least once in the past five years. These mailings contain news, information, and notice of upcoming events—such as the recent Stanford gathering with the Board of Governors and the undergraduate caucus. A third mailing, sent third class with the *Society Xaipe*, will go to the entire Society membership of almost 5,000. In the past, all three mailings were sent, usually by first class, to all 5,000 members. The Board of Governors' new policy aims to keep contributions at previous levels, while reducing total costs by \$5,000-7,500.

"Thus far, the new strategy is working successfully," said Society Treasurer David Ehrlich, S '84. "But, we need a successful final mailing in this academic year in order to balance our budget for the seventh year in a row."

Undergraduate Caucus Report

The Alpha Delta Phi Society's undergraduate caucus met at the Stanford Chapter the weekend of April 9-11, 1999. Thanks to the Society's financial support, including travel expenses, at least two undergraduate members from each of the Society's six chapters attended the caucus.

The issue of the proper way to wear the Badge has come up repeatedly at undergraduate caucuses. After these discussions, the Board of Governors asked the undergraduates to develop a uniform Society policy. After a constructive debate, all the chapters agreed to create a policy that allows the Badge to be worn openly on formal attire. This will be a topic for discussion and approval at the Fourth/ 167th Convention at Columbia in October.

The caucus also discussed possible awards to be given at convention. One such award is the Society Sword and Spear, recognizing the outstanding Society undergraduate. Each chapter nominates a maximum of two people from the senior class or the class that graduated since the previous convention. This award requires a college transcript and recommendations from college deans, Alpha Delt undergraduates, and Alpha Delt graduates. The first Society Sword and Spear will be awarded at the Fourth/167th Convention at Columbia.

The undergraduate caucus also entertained ideas about a Most Improved Chapter award or Most Outstanding Chapter award, but decided that a community of six chapters did not require awards of this sort. More specific rules were agreed to in order to better control the traveling trophies ("Travelling Trophies").

Over the course of the last semester, work towards a standard Society pledge manual has progressed. The caucus decided that it would be difficult to teach everything that has currently been developed for the manual, and decided to have a "core" section of required material and a "reference" section of additional information that each chapter may teach or that individual pledges may read.

The "core curriculum" will include the structure of Alpha Delta Phi (International, Foundation, Fraternity, Society), ideals of membership, the biography of Samuel Eells, the founding of Alpha Delta Phi, the history of coeducation in Alpha Delta Phi, the literary tradition, symbols and insignia, and the Society Chapters and the order of their founding. Recommended additions are the names and hometowns of chapter members and the officers of the local graduate organization.

The goal is for the pledge manual to be approved at the Fourth/167th Convention at Columbia.

Finally, the caucus elected a new undergraduate governor to replace Thomas Clark, BDN '99, whose term had expired. The new governor is Michael Cadette, BDN '00. The Undergraduate Caucus thanks Thom for his hard work and effort, and looks forward to the following year.

Columbia's new student center. The Columbia Chapter House will be the headquarters for delegates and other undergraduate and graduate attendees.

Board of Governors Meet at Stanford

The Stanford Chapter and Graduate Organization hosted the latest meeting of the Society's Board of Governors the weekend of April 9-11, 1999. In addition to the business meetings, governors participated in a banquet, met with undergraduates, and visited the former chapter house.

The Board of Governors met on April 10 to work through a 35-point agenda. In addition to discussions about the Society's finances, the board discussed the ratification of the new Society Constitution, consulted with the undergraduate caucus on establishing an awards program, decided to hire a summer intern, were updated on the status of the Bowdoin Chapter, and discussed a Society heritage preservation program.

Society Treasurer David Ehrlich, S '84, reported to the Board of Governors that the Society's financial results through three quarters (July 1 through April 1) were onbudget. However, he cautioned that the Society faced several high-expense events in the coming months, including the Stanford Board meeting and undergraduate caucus and the Fourth/167th Society Convention to be hosted by the Columbia Chapter in New York City. Ehrlich emphasized that a strong response to the May fundraising letter was needed in order to allow the Society to record its seventh consecutive balanced budget.

President Robert McKelvey, MID '59, reported that the Society's endowment continued to perform ahead of comparable market indexes. During the past year (April 1, 1998 though March 31, 1999) the Society's endowment gained 9.46% in value, and now had a value of \$88,805.

Governor Pam Coukos, BRN '90, reported on the ratification process of the proposed Society Constitution that was adopted by the Third/165th Convention hosted by the Bowdoin Chapter. She said that enough chapters have now returned their ratification paperwork in proper to meet the ratification requirements of the Constitution. As a result, the Society now has a newly ratified Constitution to govern its activities. Printed and bound copies of the new Constitution will be distributed at Convention.

After consulting with the undergraduates, the Board of Governors decided to establish a Society Sword and Spear Award. The first Society Sword and Spear Award will be awarded during the Fourth/167th Convention at Columbia in October 1999. The application deadline was set for July 15.

The Board of Governors decided to seek applications

for a summer intern. The intern would help plan the Fourth/ 167th Convention at Columbia and assist the Stanford and Columbia Chapters with an update of their member directories.

Governor Craig Cheslog, BDN '93, reported on the status of the Bowdoin Chapter and the college's recent decision to abolish its Greek system at the end of the 1999-2000 academic year. He added that it was the intention of the Bowdoin Chapter's graduate organization to keep the chapter house open until the last possible date in order to allow the last class of Bowdoin Alpha Delts to live in the chapter house until they graduate. Cheslog also told the board that the Bowdoin Chapter's graduate organization is considering what to do with the chapter house once the chapter is forced to close. The Board of Governors reiterated that they were prepared to assist the Bowdoin Chapter in this process.

Governor A. Paul Neshamkin, COL '63, asked members of the Board of Governors to continue to solicit suggestions for people who may wish to become active in the Society's governance. On behalf of the Nominations Committee, Mr. Neshamkin nominated Kari A. Dahlen, BRN '96, to the Society's Executive Council. Ms. Dahlen has agreed to assist the Columbia Chapter and the Board in the preparations for the Fourth/167th Convention.

The Society's historical artifact preservation program was also discussed. Mr. Neshamkin said that he has started to save some of the artifacts in electronic format. The board also noted that the final disposition of the Bowdoin Chapter's artifacts must be a priority of the Society. At President McKelvey's suggestion, the Board of Governors agreed that the artifact preservation issue should be a major discussion item at the upcoming Convention.

Last fall, the Board of Governors decided to send two first-class mailings to any Society member who had contributed in the past five years. The third mailing, including the *Society Xaipe*, will be sent third class to the entire membership. The Board of Governors' objective is to keep contributions in the \$15,000-20,000 per year range while cutting expenses almost in half.

So, if this is the first time you have heard from us this year, you now know the reason. We hope you will fix it by letting us hear from you.
