The Middletown Chapter hosted the 18th annual Society Convention and Leadership Conference in March at Wesleyan University in Middletown, Connecticut.

To accommodate one of the highest attendances in the Society's history (representing all 12 chapters and affiliates), Convention business sessions were held in the campus' largest lecture hall in Exley Science Center—a testament to how Convention has grown over the past few years.

providing need-based reduction to the New Member Fee took hold among the Convention attendees.

Looking Back, Looking Forward: Reflections from the Society's New President

The last (nearly) 26 years have been impressive, from any standpoint. From the four initial chapters in 1992, we've managed to spread to a total of 14 schools overall. And while our expansion efforts haven't always been successful, in the cases where it has worked, our organization is strong, with enthusiastic, devoted undergrads who never fail to impress me with what they do.

But at the same time, there's room for improvement. One of the biggest comments that I hear from new Governors is that they're not sure what they should be doing, even after being on the board for over a year. We have directors who are unclear on how to reach their goals and undergrads who have felt hamstrung by what seems like unnecessary red tape.

My answer to most of this is to dramatically increase communication at all levels of the organization.

Vice President Dena Schwartz, Penn 2013, is working to produce an onboarding guide for new Governors, so it's clearer what is expected of them, and how they can most effectively serve the Society. Treasurer Laura Hellwig, Capital 2016, is working directly with Undergraduate President President Cailyn Hansen, Brunonian 2019, and Vice President Nora Hennessey, Capital 2019, to make it easier for undergrads to access the money budgeted for their activities.

At the Presidential level, I am attempting to speak with all the leaders of the Society on a regular basis—this includes weekly calls with Executive Director Michael Blitstein and Vice President Dena Schwartz, monthly calls with Secretary Alina Lacombe, Capital 2015.5, Treasurer Laura Hellwig, and the Undergraduate Parliament leaders. I am also speaking quarterly with each of the Directors, and every six months with each of the Governors.

The purpose of all these calls is straightforward—what have you done since the last call, and what are your goals before the next?

So far, this seems to be working. At the Executive level, we're passing information much more quickly than we

had previously, and we're having a much more in-depth discussion than we were via email. We've been able to get much more feedback from the Undergraduate level and react to it more rapidly.

I hope to eventually expand this to include regular calls with the Chapter leadership as well, at both the Undergraduate and Graduate level, to ensure that we're directly hearing the voices of leadership across all levels of the Society.

The second area where I hope to further mature the organization is by formalizing our operational processes. By this, I don't mean by adding more red tape, but rather to look at those aspects of the organization that have been previously handled by volunteers, documenting them, and ensuring that we have continuity moving forward.

Our first major project in this area will be dealing with our IT infrastructure. Over the next couple of months, we will begin the transition to using G Suite for things like DNS and mailing lists. This will also allow us to centralize our Google Drive and Docs offerings, so that we no longer rely on individual accounts, but instead have something controlled at an organization level, and that can be easily used to provide access to both the Board and the Undergraduates. Finally, we will create individual *(Continued on page 10)*

Congratulations to the 2018 Alpha Delta Phi Society Award Honorees

The Alpha Delta Phi Society honored six siblings during the 2018 Convention Banquet with awards to celebrate their outstanding contributions to the Society.

Society Order of the Sword and Spear

The Society Order of the Sword and Spear is the highest undergraduate honor recognized by the Society and recognizes a member who has done outstanding work for their chapter, campus, community, and Society.

This year, Sarah Weinbrom, Capital 2017, received this honor.

Sarah is a founding member of the Capital Chapter and has held leadership positions such as Chaplain,



Pledgemaster, Recruitment Chair, and Philanthropy Chair. She also held leadership positions of Vice President and Community Service Chair in Epsilon Sigma Alpha, a service organization addressing hunger, homelessness, and other problems in Washington, D.C.

During her time as an undergrad, Sarah was part of GlobeMed, an organization with a GW Chapter that partners with a group in Uganda that helps women formerly involved in sex trafficking. When she wasn't in school, Sarah spent school holidays in Oklahoma, New York, and Florida, where she volunteered in underserved communities as part of GW's Alternative Breaks program.

Star and Crescent Award

The Star and Crescent Award is awarded by the Society Board of Governors to a graduate member who has made an outstanding and lasting contribution to the Society; it is the highest distinction bestowed upon a graduate member of the Society.

This year's winner was Joan Charlotte Matelli, Middletown 1992.

Joan Matelli has loyally served the Alpha Delta Phi Society for well over a decade. Just re–elected to her third term as a Society Graduate Governor, she currently serves on the Member Safety and Lifelong Experience committees, and supports the New England Regional Graduate Organization.



In 2013, she co-authored the Policy Statement to Promote Consent and Communication, which was unanimously passed at the Society's 13th Convention. She has been actively involved in the Society's expansion efforts, and continues to mentor undergraduates and young alumni of many of our new chapters and affiliates.

A fierce advocate for quieter voices, she encourages diverse opinions and perspectives to be shared and heard in the governance of the Society. The Star and Crescent award honors her boundless compassion, her spirit of generosity and kindness, her grand enthusiasm, and her persistent dedication to embodying the ideals of the Alpha Delta Phi Society.

Emerald and Pearl Award

The Emerald and Pearl Award recognizes outstanding contributions to the Alpha Delta Phi Society at the national level, and secondarily, exemplary contributions to the member's chapter.

For the first time in its short history, the Emerald and Pearl was given to two siblings this year: Carolyn Dundes, Middletown 2017, and Kylie Madden, Capital 2017.

Carolyn recently graduated from Wesleyan University, where they served as the Middletown Chapter's Secretary. Before that, they were the Chapter's Chaplain, where they were consistently praised for their deep level of empathy.

At the National level, they served as an Undergraduate Governor where they helped facilitate a Society–wide *(Continued on page 11)*

An Appreciation of our Outgoing President

We would like to offer our most heartfelt thanks to outgoing Society President Kristen "K2" Soule, Brunonian 1999.

A member of the Board of Governors since 2011 (and still serving for two more years), Kristen's tenure would already be noteworthy as she was the first female President of the Alpha Delta Phi Society. But her legacy goes far beyond that.

During her time as President, the Society added two additional affiliates to our ranks, Ursinian and Rensselaer, and the Capital Affiliate achieved full Chapter status. She created the position of Executive Director, with Michael Blitstein being the first to serve in that position.

But by far, the most lasting legacy from Kristen's Presidency was the revised Fraternity–Society Agreement, passed in 2017 (the November 2017 edition of the *Society Xaipe* covered these developments in depth, and you can find an archive on the Society's website at <u>www.adps.org</u>).

As the only substantial update to the agreement since it was originally signed in 1992, the revised agreement finally brought us to parity with the Fraternity, removing restrictions on the use of letters, and better enabling us to expand at will. Thank you, Kristen, for all you've done!

we take for granted and Rob has been a key individual who helped us reach this point. Since 1997, Rob has hosted our society website and listserv infrastructure, providing regular tech support and advice in a crisis, all without expecting anything in return.

I started working with Rob in 2013, when I needed help testing out a new setting on our listserv, in order to prevent secret emails from reaching our pledges ("Shhh...they don't know that yet"). Rob responded in less than two hours. He was helpful and informative and proactively warned me that he would be unresponsive for a day due to travel. The last five years were exactly like that. Whether it was creating the dozens of new listservs requested as our society leadership and undergrad involvement has ballooned or debugging the latest Yahoo spam issue or assisting in a crisis like the day I accidentally deleted the website, Rob has always been helpful. over two days to discuss subjects meaningful to them. The usual conversations on how to keep chapters alive and thriving took on a newfound urgency, in light of the Stanford Chapter and the Plattsburgh Affiliate closing their doors just prior to Convention weekend.

Siblings young and old passionately vocalized their opinions regarding Affiliate Chapter voting rights on the national level. Spurred by a renewed emphasis on the Phi's lifetime relevance, Chair of the Lifelong Experience committee Peter Goldstein, Brunonian 2008, launched a pilot ADPS Mentoring program with six pairs of eager mentors and mentees. And an endeavor to revamp the Society's online meme page was met with much participation and enthusiasm.

Inclusiveness, equity, and diversity in our Society remained major topics throughout the weekend. Siblings Andy Richards, Brunonian 2017; Carolyn Dundes, Middletown 2017; Richie Leng, Brunonian 2014; and Zach Wilson, Brunonian 2012, worked tirelessly to author a Statement of Values on Diversity and Inclusion. *(Read more about this document on page 10.)*



The Inclusion committee held two sessions for sibling commentary and additions to the document before it was unanimously passed by the Convention. A resolution was also approved to create an action plan for fulfilling the Statement of Values' principles in measurable ways.

Complementing the ratification of these momentous documents was the Educational Programming Committee's guest speaker—artist and activist Lara Americo. Americo's compelling personal stories and question and answer session with the audience sparked dialog about how to be a better accomplice with the queer individuals in one's life, siblings or otherwise.



For the sixth year in a row, the Development Committee organized a Convention Donation Matching Challenge to encourage young and first-time donors to contribute to the Society. The weekend broke records: 86 young donors contributed over \$2,800, with a total of \$33,450 raised.

The Development team also refused to be outdone by last year's banquet shenanigans. At the conclusion of dinner, three random donors were drawn from a hat and won the prize of smashing a pie in the face of volunteers Jenny Flanagan, Middletown 1983; Jack Kelly, Brunonian 2018; and Michael Sugarman, Binghamton 2018.

What began as an auction for rights to pie Governors Christine Chapman, Brunonian 2014, or Zach Wilson, Brunonian 2012, escalated into a massive group of siblings bidding for Christine's privilege to pie Zach—an epic event that attendees (and the Internet) will never forget. The banquet itself featured awards and literary exercises throughout, including jarring remixes of *I'm On A Boat,* interactive Mad Libs games, and many alter–egos of Thom Clark, Bowdoin 1999.

The Middletown undergraduates and alumni made an impressive effort to host visitors and infuse the weekend with a Wesleyan flavor. Guests enjoyed a Friday night visit to the locally owned Middletown Roller Rink and a performance by Wesleyan's fire–spinning group, Prometheus. Middletown undergrads closed the Convention with a Friar Cup election traditional of Middletown Chapter meetings, where President Lex Jimenez, Middletown 2019, solicited audience nominations for the most siblingly acts of the weekend.

New Initiatives from the Diversity and Inclusion Committee

Delegates to the 2018 Society Convention adopted a new Statement of Values on Diversity and Inclusion. This document, along with several other proposals made by recently established Diversity and Inclusion Committee, marks the beginning of a push to ensure the Society will be able to engage with and support all of its members.

The Statement of Values on Diversity and Inclusion is a document that exists to define what diversity and inclusion mean to the Society, as well as to promote practices that will embody the Society's ideals of siblinghood. The document was discussed and final changes were made at Convention, after which the statement was voted on and adopted. The statement, which can now be found on the Society Leadership Resources webpage (www.adps.org), is only one step that the Diversity and Inclusion Committee intends to take in the upcoming year.

The Committee, recognizing that the Society was born out of principles of inclusion, aims to foster that inclusivity and ensure that the Society is doing everything possible to welcome and affirm every member. At Convention, the Committee also resolved to create an action plan with the hope of best identifying measurable efforts to embrace diversity and inclusion.

One of the focuses of the Committee so far has been to encourage the Society to use inclusive language across all communications. To further this effort, the Committee proposed updating the Constitution to use "their" and "them" instead of "his or her" and "he or she" in order to best represent the Society and all of its members. This resolution was also adopted at Convention, with an amendment to the Constitution to follow.

As its efforts to promote inclusive practices across the Society develop, the Diversity and Inclusion Committee remains excited to contribute to the Society's growth over the next several years.
